- 1. Meeting called to order 1332 hrs. Charlie Howell/ Pledge of Allegiance
- 2. Public Comment/Correspondence: None
- 3. Action Item: Approval of current Fiscal Statements/Invoices: After a short discussion,

Commissioner Bolduc made a motion to approve payment of invoices as presented for payment in the amount of \$13,200.28 for the "B" Budget and \$173,356.95 for the "A" Budget. Second by Commissioner Wood. All in favor, motion passed.

4. Action Item: Approval of the minutes from October 16, 2024:

5. Directors Report:

- a. Staff Report Dispatch: 15 full-time, the 3 trainees on the floor and doing well. We have 3 part-time, three candidates in background. Possibly losing one this summer.
- **b. Public Events:** SIRCOMM participated in the Jerome "Trunk or Treat" and will be a part of the "Christmas in Park" also.
- c. **CAD Updates:** The CAD will be down on November 25th from 8:00 am to 12:00 pm. All dispatch, portal, "Field Op's," "MDT'S, and "AVL's" will be down. Everything will need to be entered by hand the old school way. All events will need to be manually input after the update.
- d. CAD2CAD Update: A test was conducted on October 30th and was not successful. CentralSquare was unable to connect to the SIRCOMM side of the HUB. It is a 100% CentralSquare issue. It was noted that both PSAPs were charged and paid for this feature four years ago. The JPB Board has asked SIRCOMM Legal for any recourse SIRCOMM may have. It was also noted that Fire Chief Les Kenworthy authored a letter and it was signed by the heads of every department with a vested interest in the project, and then sent to CentralSquare. SIRCOMM Legal was asked to immediately begin to pursue CentralSquare on answers to all questions regarding this issue.
- e. Tabletop Exercise with Twin Falls City-Planning Phase: Several agencies from both sides of the bridge (the event is planned to take place on the bridge) are working together through the scenario for the exercise being planned for in April.
- f. Fall Generator Preventative Maintenance/Gooding Site: LG HVAC is the process of

- repairing/replacing the blower at the Gooding Tower site.

 Commissioner Howell asked how many repeaters were still needing replaced, to which the Director shared that there are many and several have been ordered.
